The Season of Comfort Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Period. The Season of Comfort Sweepstakes (the "Sweepstakes"), sponsored by Nutramax Laboratories Consumer Care, Inc.
